#### Why are we doing this now?

At CANDJ, we wanted to support the [CAND's 2025-2028 Strategic Plan](#) to foster a more collaborative profession nationally. We agreed that transitioning to open access would be a powerful way to show that we are serious about transparency and open scientific enquiry. We also wanted to remove barriers that many NDs around the world still face in accessing evidence-informed and clinically relevant articles. We felt the time was right to show what we can do as a CAND-supported, not-for-profit, peer-reviewed, and indexed journal.

This open access project was a coordinated effort from our editorial, publishing, and Association teams. We are very thankful for the many people who contributed, including our CEO, Gemma Beierback, who saw the

potential of an open access CANDJ back in January/February, and our publications lead at SG Publishing, Laura Hope, who did an enormous amount of behind-the-scenes work to ensure all the necessary details were in place to transition our article licensing to Creative Commons.

Now it's time for us to show our work.

## Naturopathic Legacy Project

THE NATUROPATHIC  
LEGACY PROJECT

Acts regulating naturopathic medicine in the provinces and territories of Canada date from the early 1900s to non-existent. Today, 6 provinces and 1 territory are regulated under provincial legislation.

Government ideology and political pressure are often key factors in regulatory decisions. Alberta and BC are interesting examples of this.

NDs in Alberta had been regulated since 1950 under the Drugless Practitioners Act, becoming the Naturopathy Act in 1952. In 1986, in response to an unfortunate child death under the care of an ND, that Act was repealed and the profession undertook self-regulation through the newly incorporated Alberta Association of Naturopathic Practitioners. Despite government reports from 1990 recommending the inclusion of Naturopathy under the then Health Disciplines Act, it was not included until the Health Professions Act 2000. Full regulation began in 2012 when the Regulations were approved and implemented.

From 1936 to 2000, BC NDs had been regulated under the Naturopaths Act, becoming the Health Professions Act, regulated by the College of Naturopathic Physicians of BC. In June 2024, the BC government forced the amalgamation of naturopathic medicine, chiropractic, massage therapy, TCM, and acupuncture under a shared Act and regulatory college, the College of Complementary Health Professionals of British Columbia (CCHPBC).


